- Conveyancing Law and Practice Level 4 (credit value 50)
- Conveyancing Law and Practice Level 6 (credit value 44)

## WHO WOULD BENEFIT FROM STUDYING THE DIPLOMAS?

**THE** diplomas are an excellent way for property professionals to gain a greater insight into the process of Conveyancing, to expand their knowledge and feel confident in working with property lawyers and solicitors who are acting on both sides of a sale and purchase of a property.

**THE** qualification is suitable for anyone who works closely with clients and are often involved in explaining and supporting them through the process of buying, selling, or renting their property.

IT is also a helpful qualification for those working on large scale residential developments, especially those individuals who are often the first point of contact with potential buyers, many of whom may be first time buyers who are seeking guidance and reassurance about the processes of buying or renting their first home.

individuals working in Estate Agency, Property
Development, Lettings, and Management, the
opportunity to gain real insight into the stages of the

involved in residential conveyancing.



# DO CANDIDATES NEED TO BE EMPLOYED IN A LEGAL PRACTICE?

**CANDIDATES** do not need to be in conveyancing employment, or working in a legal firm in order to successfully complete the Diplomas. The CLC qualifications are designed so that candidates can build-up their knowledge of the key principles of law, before applying what they have learned to a number of practical scenarios that are based on standard residential conveyancing processes.

### WHERE AND HOW CAN THE DIPLOMAS BE STUDIED?

THE CLC Diplomas can be studied by online Distance Learning, which make them very suitable for people who are already working on a full-time basis, and they can be completed in as little as 18 months. Delivery of the diplomas through a number of training providers ensures a variety of study programmes and exam centres in various locations around the country. Training providers offer a number of ways to pay, including interest free payment plans aimed to help candidates and employers to spread the cost of professional development.

**THE** Level 4 Diploma consists of five separate units. Four of the units are assessed in the students own time and the fifth is assessed by a short exam. This means that candidates can work at a pace of study that is right for them and their employer. Successful completion of the Level 4 Diploma will also add value to the business, enabling individuals to offer specialist residential property knowledge and guidance to clients within any residential property environment.

#### INCREASING YOUR PROPERTY KNOWLEDGE CAN HELP TO CREATE BUSINESS GROWTH

**INDIVIDUALS** working in Estate Agency, Property Development, Lettings, and Management with in-house legal services, may consider the Level 6 Diploma (degree level) which will help to broaden their legal services knowledge as it will also include conveyancing to the public.
